# FCC Annual Meeting Minutes - 01/29/23

#### Congregational Meeting 1/29/23

The membership met with the purpose of hearing reports, electing officers, approving the annual budget, and transacting any other pertinent business.

Meeting was announced for 2 prior Sundays as required by by-laws.

#### Total votes 99; 37 online and 62 paper. (See attached for breakdown)

- I. Meeting called to order by Howard Tejchma at 11am.
- II. Invocation by Sarah-Schmidt-Lee.
- III. Confirmation of quorum (at least 27 based on current congregational numbers).
- IV. VOTE TO ACCEPT MINUTES for the prior 2022 congregational meetings. *Motion by Maggie Bresz, seconded by Heidi Oberlin; Passed.*
- V. VOTE TO ACCEPT BY-LAWS CHANGES (As first communicated December 27)
- **#1 Change:** Electronic Voting; we have used electronic options to vote since 2020 and we believe it will continue to have value. This formally gives Council the decision to make it an option. *Motion by Derl Oberlin, seconded by Edna Thompson. Passed.*
- **#2 Change:** Expand the trustee group from 3 (Moderators) to 7, adding Treasurer, 2 assistant Treasurers, and Clerk, assuring we don't fall under 3. *Motion by Kristi Droppers, seconded by Warren Cook. Passed.*
- **#3 Change:** At-large members reverted back to 2 from 3, based on revised membership numbers of 270. *Motion by Derl Oberlin, seconded by Edna Thompson. Passed.*

#### VI. VOTE NOMINATIONS FOR NEW LEADERS AND TRUSTEES

- **a. Moderator-Elect.** Motion by Peggy Johnston to vote to put this position on hold until spring, seconded by Pam Walker. Passed with unanimous hand and Zoom vote.
- **b. Treasurer.** Vote to affirm Carol Dunleavy-Chandler as Treasurer for a 3 year term. *Motion by Gregory Greenman, seconded by John Idema. Passed.*
- **c. Clerk.** Vote to affirm Ginny Stapleton as Clerk for a 2 year term. *Motion by Peggy Johnston, seconded by Don Nelson. Passed.*
- **d. Assistant Treasurers.** Vote to affirm Phillip Micklin as 1st Asst. Treasurer for a 1-year term, Don Nelson as 2nd Asst. Treasurer for a 2 year term, and Gregory Greenman as 3rd Asst. Treasurer for a 3 year term. *Motion by Linda Powell, seconded by Bill Maxey. Passed.*

#### VII. VOTE NOMINATIONS FOR OTHER VOTING COUNCIL LEADERS (leaders

**listed on #9 of ballot)** Motion by Jeannette Maxey, seconded by Coco Cook. Passed.

#### VIII. TREASURERS REPORT/VOTE FOR 2023 BUDGET AND ACCEPT AUDIT

**a. 2023 budget** will be a continuation of 2022 budget for up to 4 months. Tom reported a clean audit by Seber Tans for a 3 year period. Council approved the draft audit, and it is now complete. A comment was raised by Peggy Johnston regarding Worship Arts budget for 2023, to be discussed in Council. *Motion to affirm 2023 budget as a continuation of the 2022 budget for up to 4 months by Gregory Greenman, seconded by Don Nelson. Passed.*

There are fewer pastors looking for work than churches looking for pastors! **#3** Gregory Greenman moved to establish a new bylaws charter and committee in the coming year. *Motion by Peggy Johnston to approve, seconded by Kimn Licavoli*.

# **Moderator Report**

Like most people in their late 60s, my memory of details from a year ago is not great. However, I'm a big believer in Maya Angelou's quote about how we often forget what is said or forget what we or others have done, but we never forget how we felt. I remember feeling anxious a year ago as I began my Moderator role.

At the start of 2023, we were just starting to figure out where we, as a church, landed after a pandemic as we moved beyond our own church crises. We survived and thrived because of the interim leadership led by Caroline Meyers and Sarah Schmidt-Lee, along with the work of our staff and the steadfast dedication of Howard Tejchma as Moderator.

Through discussions and observation, I focused on four goals.

- 1. Find additional new members for the HR Team.
- 2. Change the tenor of Council meetings in support of greater collaboration.
- 3. Support the new pastor and ensure his/her success.
- 4. Increase the congregation's understanding of how we govern ourselves and operate.

The HR team lost many members in early 2023, and I committed to finding individuals with in-depth experience in hiring, managing, or running organizations to join the HR team. It took time, but we have successfully created a team of dedicated individuals who bring their experience regarding decision-making, interviewing, consensus building, and process management to the collective.

No one likes meetings. And Council meetings are notoriously long. Despite the long meetings, the Council has accomplished much this year. Including new standardized ministry team charters, we ushered in a new Sr. Pastor, audited our church rolls, documented ministry team budgets, agreed upon church priorities, revised our bylaws, and more.

Just the same, I have been committed to making Council meetings even though they are long, filled with ease, fellowship, and comradery.

The best leadership teams work from a foundation of trust. It is not easy to create and not something that can be mandated. I attempted to encourage discussion and more dialogue beginning with a Leadership Retreat in March and in our monthly Council meetings by changing the agenda and inserting time for reflection. We've made progress, as noted by my own level of anxiety and in the bursts of laughter in our meetings and increased discussion. This has signaled to me that we feel safer as a community.

Whatever anxiety I had the first six months of this year slowly went away after Pastor Mary started in her role as Senior Pastor on June 1, 2023. I was committed to making Mary a success, but it didn't take long to realize that she needed no assistance from me to establish herself as head of staff and Senior Pastor of our congregation. God listened to all our prayers and answered them when he pointed Mary Austin toward us. She has been a partner to me in this role, which has benefited me immensely, and I only hope I have been of some help to her.

The last goal on my list was to leverage my communication skills to help clarify how we, as a church, work and govern ourselves. Therefore, I have been committed (probably oversharing for some congregants) to sharing the "what, why, when, and how" whenever news or announcements need to get out to the congregation. My intention has been to be transparent and informative. I hope I have done that from time to time.

Like past Moderators, I consider the best take-away from being a Moderator is my interaction with other congregants and staff, which might not have happened if I was not in this role. And some of those interactions have become real friendships and a blessing for me.

In my less anxious state, my goal now is to support Heidi Oberlin as moderator. I love this role!

# **Communication Team**

#### **Accomplishments in 2023:**

- In January we pulled together an FCC Tech Fair after church with the goal of educating members on how to engage with FCC via electronic apps and specifically Breeze.
- Created an Instagram account and Pastor Sarah offered to leverage her creative skills to manage both our Facebook and Instagram social media sites resulting in multiple posts and new online engagement.

Polly Blowers took the lead on most of these projects that included:

- Revamped the emailed e-spire with a new masthead and ease of scrolling.
- Rework of the weekly Worship email that included the bulletin, log-in for online worship and direct link for offering.
- Overhaul of the paper bulletin on a larger paper size that saves paper and dollars.
- Updated the church logo with fresh and more contemporary typeface, boxed sizing making it easier in electronic communication and added rainbow colors in the traditional comma (UCC 's "God is Still Speaking Comma").
- Cut back substantially on mailing information to members, saving us both postage and paper costs.

#### Looking ahead to 2024:

The Communication Ministry team is changing. We will no longer have representation on the Church Council but will instead function as a support team to the church with Polly Blowers remaining as our staff liaison.

In the coming year we have big plans. Those plans include:

- Revamping our church website making it more appealing to people shopping for churches and an easier resource for our members.
- Advertising via social media about our church events to attract community members to join us.
- Hiring a part time Communications Coordinator that can assist with AV, social media, photography, and graphic design, etc.
- Promotional banners for our permanent outdoor signage boxes.
- Upgrade our AV equipment [Phase 1.]. This initial phase will focus on new cameras and ease of controlling them from the AV stand.
- Educating ministry teams on how to leverage Breeze to complete their work and congregants on how to use Breeze to find information.
- Completing the goal of having 100% of all members' photos accompanying their names in the Breeze directory.

# **Worship Arts Team**

#### **Accomplishments in 2023:**

- Weekly anthems/music in worship complimenting overall service themes.
- Special music for Lent, All Saints Sunday, Advent season and Christmas Eve.
- Children/Youth programming through WoW activities/participation in worship.
- Growth of Spoken Word Ministry.
- Collaboration with other ministry teams for special projects and programs including Messiah Sing, Hanging of the Greens, Bronson Park caroling (to name a few).
- Continuity and smooth transition of music programming during hiring process for an interim Music Director, with support from music staff, Section Leaders, and Choral Scholars.

#### Goals for 2024:

- Support and advocate for all music staff.
- Lend support and assistance in securing a permanent Director of Music.
- Grow the Chancel Choir and expand music repertoire.
- Maintain a strong program of Section Leaders and Choral Scholars
- Plan for the Chancel Choir to perform a major work.
- Begin planning for events for the anniversary of the sanctuary organ.

#### **Human Resources Team**

Purpose: To oversee all aspects of the human resource affairs of the Church, serving as a resource and support to the Council, Ministry Teams, Pastoral Relations Committees, and staff, including lay staff and pastors, with respect to personnel, employment, and workplace-related issues. The HRMT works in consultation with FCC leadership, pastor/s, and administrative staff to establish policies and procedures pertaining to all aspects of employment including hiring, termination, compensation & benefits, standards of conduct, and performance reviews.

#### **Accomplishments in 2023:**

- Recruited new members to give long-standing members a break after a long tenure.
- Received Council approval on a revised team charter to clarify process and team membership.
- Received Council approval of Safe Conduct Policy with procedures. Thanks to Rick Johnson and Pastor Sarah for their work in making this possible.
- Interim Director of Music Established a search and hired an interim director Jeff Cachero, who will continue through the rest of the choir season.
- Bell Choir Director Hired Jamie Sue Knight to direct for the full season.
- Completed staff reviews by spring of the year.
- Received Council approval for Pastor Sarah's sabbatical to commence April-August 2024.
- Onboarded new Senior Pastor Mary Austin, and worked collaboratively with her on HR needs as she assumed the role of Head of Staff.

#### Goals for 2024:

- Review and update the Employee Personnel Policy book last updated in 2016.
- Run a Safe Conduct Policy training drill so the committee is prepared to respond.
- Hire a permanent Director of Music.
- Work on procedures related to HR responsibility (hiring, reviews, etc.).
- Continue to review roles, their scope and ministry needs, and develop updated job descriptions.

#### **Finance Team**

The purpose of the Finance Team is to oversee all aspects of the financial affairs of the church. The team is responsible for prudently investing all the church's funds, preparing the annual budget, ensuring that appropriate systems, policies, controls, and procedures are in place to protect and report on the financial condition of the church.

#### **Accomplishments in 2023:**

- Tom Powell stepped down as the long-time treasurer of First Congregational Church of Kalamazoo, Michigan, and Carol Dunleavy-Chandler became the new treasurer.
- At the annual meeting, the church membership tabled the proposed budget. A special appeal letter was sent to the members to raise additional pledge support or contributions for the budget. April, the church membership voted to accept the 2023 budget.
- Caroline Meyers, Tad Drabik, and Carol Dunleavy-Chandler conferred with the Irving S. Gilmore Foundation to discuss additional funding from \$30,000.00 to \$35,000.00. The administrator of the Foundation was very encouraging of our request.
- Breakwater, financial advisors to FCC, proposed a sophisticated strategy approach to Climate, Social and Governance investment. Breakwater presented it to the committee in August and the committee in November voted unanimously to accept the proposal effective January 2024. The proposal is in accordance with the investment policy of FCC.
- Mary Austin, senior pastor, and Carol Dunleavy-Chandler attended the Gilmore Foundation Celebration of Grantee's and met members of the Foundation and its staff. Tad Drabik, Tom Powell, and Carol Dunleavy-Chandler worked on the Gilmore grant request in the summer and in November, FCC, received a \$35,000.00 grant. FCC is the only Church to receive such a grant from the Gilmore Foundation.
- The Council voted to reduce staff retirement allocation from 14% to 5%. A committee studied retirement allocations of Bronson Park churches as well as Kalamazoo non-profits. The committee was comprised of Derl Oberlin, Carol Dunleavy-Chandler, Kristi Droppers and Howard Tejchma.
- A sub-committee of Finance, the Century Fund, began the work to update the legacy giving program for FCC. The committee consists of Alice Gordon, Tom Powell, Carol Dunleavy-Chandler, Derl Oberlin, Chris Schram and Dick Hudson (who passed in September 2023). The goal of the Century Fund is to promote a Building reserve for the church.
- Kristi Droppers, moderator, Mary Austin, senior pastor, and Carol Dunleavy-Chandler, treasurer, began to work on the Stewardship campaign for 2024. For four Sundays, various committees presented to the congregation their work for 2023 and goals for 2024. As of December 11,2023, pledges totaled \$380,966.00.

#### Goals for 2024:

- Hire an independent audit firm to conduct either an audit or review of FCC financial reports/statements.
- Continue our work with Breakwater to review and enhance, as needed, the endowment investments.
- Apply for a 2025 Irving S. Gilmore Grant.
- Roll out the updated Legacy giving program and Century Fund.
- Stewardship and budget 2025.

# Children's Nature Playscape

#### **Accomplishments in 2023:**

- Hosted over 4500 visits from children (a 300% increase from 2022 season).
- 41% of these visits were from children who live or attend school within The CNP Zone (the 10-block radius surrounding Bronson Park).
- Raised over \$310K toward completion of Phase 2 construction, 2023 operations, and 2024 operations.
- Loo installation is complete and paid for!
- Diversified our paid staff to better reflect Kalamazoo as a whole.
- Launched our Signature Early Learning Program, Reading, and Exploring in Nature, wherein we hosted 27 STEM activities and gave away 100 books to Kalamazoo families for FREE.
- Nurtured strong partnerships with popular and established local organizations like Rootead, Sounds of the Zoo, Gryphon Place, Goodwill Industries, KRESA, and Kzoo Parks and Rec.

#### Goals for 2024:

- Increase our CNP Zone percentage to at least 60%.
- Complete Phase 2 construction (learning pavilion and sensory garden instruments).
- Secure funds for 2025 operations.

# Kalamazoo Drop-In Child Care Center

#### **Accomplishments in 2023:**

- KDCCC served 92 families and 130 children during 2023.
- Our average daily attendance was 10. (Still recovering from Covid).
- 22 times families said they were looking for permanent housing or moving.
- 32 times families said they were looking for employment.
- 159 times families said they were attending medical or other appointments.
- 15 times families said they used KDCCC to attend Court.
- Other reasons used most often were for respite, personal time, errands, school or study or employment.
- Our numbers are still not up to what they were at pre-Covid, but each year we are getting closer.
- Our budget still looks good for the end of 2023. Our fund balance was secure in 2023 due to 2 federal one-time childcare grants in 2022.

#### Goals for 2024:

- We will be looking for ways to maintain our fund balance through 2024.
- We hope to raise our numbers to pre-Covid.
- The KDCCC board of Directors will be putting together a marketing plan to get the word out to reach more families in our community.
- We will welcome our new Volunteer Coordinator/Administrative Assistant on January 8 and train her in her new position.
